I/we hereby state that I, on behalf of my child/student and myself, am an adult, over the age of 18, and legally competent to sign this form. I/we understand these inherent risks and dangers involved with participation in the school providing its educational program and acknowledge the existence of coronavirus (COVID-19) related risks which are not obvious or predictable, and hereby intend this release to extend to injury or loss which results from both obvious or predictable coronavirus (COVID-19) risks, as well as coronavirus (COVID-19) risks that are unpredictable and not obvious and to extend to myself and my child/student, as applicable.

I/we understand that by signing this agreement I am giving up on behalf of my child/student and myself certain legal rights and remedies related to the coronavirus (COVID-19) including the right for my child/student and/or myself to recover damages in the event of death, personal and/or bodily injury of any kind, property loss or damage, expenses of any nature whatsoever including attorney's fees, and other losses that my student(s) or that I may sustain related to exposure to the coronavirus (COVID-19) in association with me or my/our child/student's participation in the Faith Christian School's educational program.
